15	Environmental and safety-related discounts/fees	
15.1	A special environmental fee is added to the tonnage-based vessel port fee in the amount of SEK 0.13 per unit of the vessel's gross tonnage. This environmental fee applies to waste disposal. The environmental fee is included in the price under group 101.	
	A general fee for sludge and oil-containing water is added to group 101, according to ship type, SEK per ton gross
